25-YEAR STAIN & FADE WARRANTY

IMPORTANT: THIS IS YOUR WARRANTY CERTIFICATE. ATTACH YOUR INVOICE AND END-TAGS TO VALIDATE.

ELIGIBILITY

This warranty is given to the original residential purchaser ("Purchaser") of WOLF PVC Porch (the "Product") and shall not be transferable. For purposes of this warranty, a residential Purchaser shall refer to a single-family residential homeowner. Inteplast Group Ltd. ("IPG") warrants to Purchaser that, for a period of twenty-five (25) years from the date of original consumer purchase (the "Warranty Period"), under normal use and service conditions:

25-YEAR LIMITED WARRANTY – STAIN RESISTANCE

The Product will resist permanent staining throughout the Warranty Period from food and beverage items that may be spilled onto the surface of the Product, including items such as condiments (barbecue sauce, ketchup, mustard, mayonnaise), salad dressing and salad oils, grease, tea, wine, coffee, fruit punch, sodas and other food and beverage related items that would typically be present on a residential deck, provided that such substances are removed from the Product with soap and water or mild household cleaners after no more than one (1) week of exposure of the substances to the surface of the Product. Notwithstanding the foregoing, IPG does not warrant that the Product is stain-proof, and does not warrant stain resistance resulting from spilled or otherwise applied food and beverage substances which are not properly cleaned as provided above within one (1) week of exposure. In addition, this warranty does not cover any staining or damage to the Product resulting from abrasive compounds of acidic or basic pH, paints or stains, strong solvents, metallic rust or other abnormal residential deck use items, and non-food and non-beverage substances, including, but not limited to, biocides, fungicides, plant foods or other bactericides.

25-YEAR LIMITED WARRANTY – FADE RESISTANCE

The Product's color will not fade from light and weathering exposure, as measured by a color change of more than 5 Delta E (CIE) units for the first five (5) years of the Warranty Period and of more than 6 to 10 Delta E (CIE) units prorated for 20 years from year six (6) to twenty-five (25) of the Warranty Period as listed in the box to the right.

While the Product is designed to resist fading, no material is fade proof when subjected to years of exposure to ultraviolet (UV) rays and the elements. All warranties are subject to the exclusions, limitations and restrictions set forth in the foregoing paragraph and below.

STANDARD RESIDENTIAL LIFETIME LIMITED WARRANTY

This Warranty is in addition to the standard residential Lifetime Limited Warranty that applies to all WOLF PVC Deck products.

EXCLUSION FROM WARRANTY COVERAGE

Surface Damage: Never use metal shovels or sharp-edged tools to remove snow and ice on the surface of any WOLF PVC Porch product. If the surface of WOLF PVC Porch is damaged or punctured after the decking is installed, including as a result of contact with shovels or other sharp-edged tools, this warranty will be voided. Paint Or Other Surfaces Applied to WOLF PVC Porch: Although WOLF PVC Porch does not need painting or staining to maintain its looks, it can be done. You can paint or stain WOLF Porch to achieve a custom color, but it is not necessary for protection as is required with wood. However, if paint or other coating materials are applied to the WOLF PVC Porch surface, this warranty will be voided. Other Exclusions: IPG does not warrant against and is not responsible for, and no implied warranty shall be deemed to cover, any product failure, product malfunction, condition or damages attributable to the following: (1) Product which was not installed in accordance with WOLF PVC Porch installation guidelines or installed in a less than workmanlike manner; (2) Product which has been structurally altered or damaged by fire, flood, lightning, windstorm, hurricane, earthquakes, tornado or other acts of God; (3) Product which has been put in unusual service, or used for purpose for which it was not designed originally; (4) Product which has not been properly stored or handled; (5) Product which has been damaged during shipment, storage, handling, or installation; (6) Product which has been damaged by movement, distortion, collapse or settling of the ground or the supporting structure on which the Product is installed; (7) Product which has exposure to direct or indirect contact with extreme heat sources (over 250 degrees) that may damage the surface of the Product; (8) Product which has staining not on the surface of the Product (i.e., the underside or the ends of the Product); or (9) Product which has been damaged by ordinary wear and tear. Purchaser is solely responsible for determining the effectiveness, fitness, suitability and safety of the Product in connection with its use in any particular application.

CLAIM PROCEDURE

Purchaser must do as follows in order to make a claim under this warranty:

Attempt to clean the affected area of the Product by using the cleaning procedures described above within one (1) week of exposure of the food or beverage to the surface of the Product. If, after completing step 1 above, the affected area remains reasonably unsatisfactory, then Purchaser must have the affected area of the Product cleaned by a professional deck cleaner at Purchaser's expense. If, after completing steps 1 and 2 above, the affected area still remains reasonably unsatisfactory, Purchaser may make a claim under this warranty as provided herein, provided that such claim is made within thirty (30) days after the professional cleaning is completed. Purchaser must, no later than the end of the Warranty Period, send to IPG proof of purchase, a description and photographs of the affected area(s) of the Product, and reasonable proof of compliance with the requirements set forth above to the following address:

CLAIM PROCEDURE (continued)

After reviewing all information, IPG will make a determination regarding the validity of the claim submitted. If IPG determines that the Purchaser's claim is valid, IPG will, at its sole option, either replace the affected item or refund the portion of the purchase price paid by the Purchaser for such affected item (not including the cost of its initial installation). Replacement material will be provided that is as close as possible in color, design and quality as the replaced material, but IPG does not guarantee an exact match as colors and designs may change.

If Purchaser makes a valid warranty claim hereunder during years eleven (11) through twenty-five (25) of the Warranty Period, then Purchaser's recovery will be prorated as indicated below. If IPG is providing replacement materials, it may elect to replace the percentage listed below of boards otherwise meeting the requirements for a claim; if IPG is refunding the purchase price, it may elect to refund the percentage listed below of the purchase price of boards otherwise meeting the requirements for a claim.

This warranty shall not cover, and IPG shall not be responsible for, costs and expenses incurred with respect to the removal of affected Product or the installation of replacement materials, including but not limited to, labor and freight. The foregoing remedies are the **SOLE AND EXCLUSIVE REMEDY FOR BREACH OF ANY WARRANTY.**

This warranty shall only be applicable and enforceable in the United States of America and Canada.

This warranty is effective for purchases by residential purchasers made on or after August 1, 2012 for Tropical Hardwood Collection and March 1, 2015 for Estate Collection.
